

Within the framework of the Law No. 6698 on the Protection of Personal Data
Saving Deposit Insurance Fund Security Camera Illumination Text

As **the Saving Deposit Insurance Fund (TMSF)**, we show maximum sensitivity to the processing and storage of your personal data in accordance with **the Law on the Protection of Personal Data (“Law”)**. In accordance with the Law, as Data Controller, we process your personal data as explained below and within the limits ordered by the legislation. In this context, we would like to inform you about our purposes and methods of collecting, processing and transferring personal data and your rights arising from the Law.

1. Method of Collection of Personal Data and Legal Reason

Your personal data is collected electronically by the TMSF; your collected personal data can be processed and transferred for the purposes specified in this Clarification Text within the scope of the personal data processing conditions and purposes specified in Article 5/2(f) of the Law No. 6698 due to legitimate interests.

2. Processing of Personal Data and Its Purposes

Your personal data; it is processed by the TMSF within the scope of Creating and Tracking Visitor Records, Tracking Office Entrances and Exits, Execution of Information and Building Security Processes.

It must be stated that; we process your personal data in accordance with the law and honesty, accurately and, when necessary, within the framework of up-to-date, specific, clear and legitimate purposes, in connection with the purpose for which they are processed, limited and measured, and for the period required by the relevant legislation or for the purpose for which they are processed. During no expressly stated your personal data in the Law, it will be processed during the existence of the valid reason and purpose for the storage of the data, and if the purpose and reason for the processing disappears or ends, it will be deleted, destroyed or anonymized.

Your personal data is not shared with third parties.

Your personal data can be shared with public institutions and organizations for the above mentioned purposes and on a limited basis.

3. Your Processed Personal Data

As stated above, **the TMSF** records and processes certain personal data belonging to you.

In this context, the data about you processed by the TMSF may include the following particulars.

- Security Camera Records
- your voice

4. Rights of Personal Data Owner

Data owners pursuant to Article 11 of the Law,

- Learning whether personal data is processed or not,
- If personal data has been processed, requesting information about it,
- Learning the purpose of processing personal data and whether they are used in accordance with its purpose,
- Knowing the third parties to whom personal data is transferred at home or abroad,
- Requesting correction of personal data in case of incomplete or incorrect processing and requesting notification of the transaction made within this scope to the third parties to whom the personal data has been transferred,
- Requesting the deletion or destruction of personal data in the event that the reasons requiring its processing cease to exist despite the fact that it has been processed in accordance with the provisions of the law and other relevant laws, and requesting that the transaction

carried out within this scope be notified to the third parties to whom the personal data has been transferred,

- Objecting to the emergence of a result against the person himself by analyzing the processed data exclusively through automated systems,
- Requesting the compensation of the damage in case of loss due to unlawful processing of personal data.

You have these rights. If you want to exercise your rights, you can contact **the TMSF** management. The contact information of **the TMSF** is presented to your attention at the end of this clarification text. In this context, if the personal data owner exercises her/his rights listed in Article 11 of the Law, **the TMSF** will fulfill the relevant requests.
